Grantee Updates

The **Mat-Su Trails and Parks Foundation** hosted six community hikes this summer. Over 100 people participated in the hikes to explore new areas, make new friends, enjoy our public lands, and participate in one of the healthiest and oldest forms of exercise in the world, going for a walk!

Visit Palmer has been busy readying their new website for those planning to visit Alaska next summer. The site, visitpalmer.com, is up and organizers are soliciting writers for current content.

Regarding the **A-Moose-Ment Park** project, much progress was made in May and July. Volunteer groups, including Palmer Rotary and faith-based groups, joined forces with **United Way of Mat-Su** and the City of Palmer to enhance and improve the park in Palmer. Many hours of service and prep were provided to improve sight lines and visibility, natural light, access to the park, and enjoyment by those frequenting the park. Currently, the City of Palmer is going through an open bidding process to determine a vendor who will provide the electrical work needed for the light poles, lights, and security cameras to be installed. We anticipate this work to begin late September-early October.
